INTRODUCTION

The Ramakrishna Mission Vidyapith, Purulia was established in the year 1958 with the object of giving a practical and concrete shape to some of the educational ideas of Swami Vivekananda. Education, in order to be effective and fruitful, must be man-making, that is, it must bring about total and integrated development of the personality of the educand. This can be achieved only when the student is brought up in surroundings where body, mind and spirit can be looked after to effloresce in a congenial environment. In this context Swami Vivekananda prescribed a meaningful system of education. The Vidyapith has adopted this system suited and adapted to modern conditions of life. Swami Hiranmayanandaji Maharaj was the founder Secretary of this institution.

SITUATION

The Vidyapith, situated on the Purulia-Barakar Road, is about 3 kms, and 5 kms, away from Purulia town and Railway station respectively. The groves of trees, expansive fields and the undulating land lend to it a beauty which is at once enchanting and calm. The campus measures more than 76 acres. On the western side of Purulia-Barakar Road the Vidyapith has another beautiful campus of 3 acres of land.

OBJECT

The object of this institution is to give an education suited and adapted to the Indian background. Great care is taken to form the character of the pupils. The Vidyapith being a time-tested institution, it is possible to give proper stress on leadership training and prepare the students to grow into empathetic enlightened citizens for a democratic society.

NEED OF AGRICULTURE

In the year 2024 the establishment of Sri Ramakrishna Temple at Purulia Vidyapith premises completed its sanctified 50 years. In compliance with the loving and noble thought of Revered Swami Vireswaranandaji Maharaj Purulia Vidyapith starts an Agriculture College from the academic year 2025-2026. Viswavidyalaya, Mohanpur, Nadia offers a Bachelor of Science in Agriculture (Hons.) course with an intake of 60 students (boys and girls) per year. This college is designed to equip students with comprehensive knowledge and practical skills essential for addressing contemporary challenges in agriculture and allied fields.

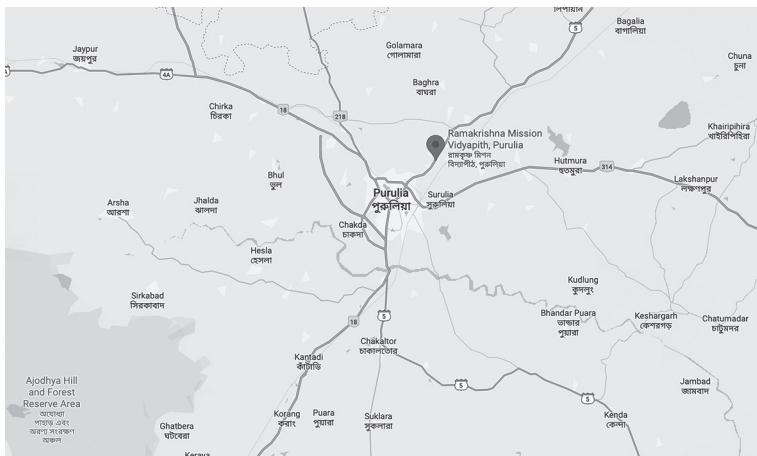

2. ELIGIBILITY CRITERIA FOR ADMISSION:

i) **Age:** Not less than 16 years as on 31.08.2025

ii) **Essential Qualification** as follows:

(Marks of English must be out of 100) Percentage of marks: Atleast 65% of mark in aggregate in the aforesaid 5(five) subjects for General/OBC/EWS Candidates and 55% for SC/ST/PwD candidates.

Every candidate must be a permanent domicile of West Bengal. Candidates will be required to submit Domicile Certificate issued by the concerned District Magistrate or Sub Divisional Officer, at the time of admission.

iii) **EWS:**

- a. EWS certificate should be issued by DM/ADM/SDO/DWO.
- b. Valid EWS certificate will be required to be submitted on the day of physical verification of certificates and admission for EWS category. Failing to submit desired certificate on that date shall lead to cancellation of the candidature.

iv) **PwD:**

The reservation of seats as per State Govt. declared policy will be followed for specific type of Person with Disability (PwD), who fulfill the minimum physical fitness, essential to pursue theory and practical courses of agricultural education.

PwD candidates, found primarily eligible for admission under this category, would be admitted provisionally. The provisionally admitted PwD candidates would be referred to competent medical authority (to be decided by the Ramakrishna Mission Vidyapith Agriculture College administration), to ascertain the genuineness of their disability, if required. In the event, any candidate is found not conforming to the prescribed disability criteria; his/her admission would be summarily cancelled.

- v) Candidates seeking reservation/ relaxation benefits available for SC/ST/PwD quota must ensure that they are entitled to such reservation / relaxation as per eligibility criteria prescribed by Govt. of West Bengal. They should be in possession of all the requisite certificates in the prescribed format in support of their claim and the date of issuance of

such certificates should be earlier than the closing date of submission of application.

vi) **OBC:**

- a. A candidate applying for OBC category must produce OBC certificate issued by the competent authority.
- b. OBC candidates only belonging to Non-Creamy Layer (NCL) category, will be eligible for admission under OBC category. A valid NCL certificate issued by the SDO should be submitted.

vii) The candidates must possess good health and capable of undertaking extensive fieldwork. The selected candidates will be required to undergo a medical examination at the time of admission. If any candidate is found physically unfit at the time of medical checkup, his/her admission is liable to be cancelled.

3. CANCELLATION OF ADMISSION:

If it is found at any stage that a candidate has obtained admission by misrepresentation and/or suppression of facts, his/her admission shall be liable to be cancelled.

4. APPLICATION FEES:

7. SUBMISSION OF SELF ATTESTED PHOTOCOPY OF THE DOCUMENTS NEEDED ALONGWITH APPLICATION FORM

a. Recent Colour Photograph with 80% face (without mask) visible including ears against a **white background**,

Birth Certificate/Certificate of Secondary Examination, Mark Sheet of Higher Secondary Examination (10+2 standard)/H.S. (Vocational Examination) [Both Side], Caste Certificate (if any), PwD Certificate (only for PwD candidates), EWS Certificate (if any), Student's Aadhaar Card, Parents' Aadhaar Cards.

- b. Incomplete application forms will be liable for cancellation.
- c. The Candidate has to submit only his/her own photograph, Certificates wherever applicable, as mentioned above (and not of anybody else) in a correct/ proper manner. In case, it is found at any time in the future that the candidate has submitted the photograph and certificate(s) of someone else in his/her Application Form, or he/she has tampered with his/her Admit Card/ Result/Scorecard, these acts of the candidate shall be treated under Unfair Means (UFM) Practices and actions would be taken as per the provisions relating to unfair Means Practices.

8. SUBMISSION OF BLOOD ELECTROPHORESIS (THALASSAEMIA) TEST REPORT:

The candidates who will be admitted after counseling are required to submit self attested copy of Blood Electrophoresis (Thalassaemia) test report to the Medical Officer, RKMVAC at the time of physical reporting and it is mandatory.

9. RESIDENCE:

Arrangement of accommodation will be made at separately for boys & girls students under the auspices of the college and this will be available for limited students. Residing in the hostel is not compulsory. Students have to arrange their accommodation of their own within Five (05) K.M distance from the Ramakrishna Mission Vidyapith Agriculture

College Campus. Admitted students will have to abide by the relevant rules and regulations of the Agriculture College.

10. ANTI-RAGGING:

Anti-ragging declaration in the form of affidavit (format to be supplied from the college authority) would be required to be signed by the admitted candidates and their guardians and to be submitted to the College Authority on the date of reporting for classes. Only after receipt of Anti-Ragging declaration, the Registration Certificate would be issued to the admitted candidates.

11. WITHDRAWAL & REFUND :

Refund of admission fee will be made to the eligible candidate as per latest UGC guidelines after successful withdrawal of studentship.

COURSE CURRICULAM

INTRODUCTION

Course Curricula for Undergraduate programme in Agriculture UG- Certificate in Agriculture UG-Diploma in Agriculture B.Sc. (Hons.) Agriculture based on 6th Dean's Committee has been prepared as per National Education Policy-2020 guidelines to build among students, a strong foundation of knowledge and increased practical exposure to instil competence and confidence for application of the professional knowledge coupled with hard and soft skills.

More emphasis has been given on Skill Enhancement Courses, industry attachments, flexibility in choice of courses via electives offered in fourth year and also through online courses along with provision of project work and internship. Provision of UG-Certificate in Agriculture, UG-Diploma in Agriculture and B.Sc. (Hons.) Agriculture degree with internship with amalgamation of multiple exit and entry options as per NEP-2020 is important change in the course curriculum.

HIGHLIGHTS

The B. Sc (Hons.) Agriculture program will be of 177 credits, which will have 167 credits offered by the parent university and 10 credits of online courses taken by the student as per choice in consultation with university/HAEIs.

After the admission in the college, the students will register for the Foundation programme of 2 weeks' duration in the 1st semester. A course entitled Deeksharambh (0+2) (Non-gradual) will be offered at the start of first semester for two weeks' duration. This will create a platform for students to learn from each other's life experiences, help for cultural Integration of students from different backgrounds, know about the operational framework of academic process in university, instilling life and social skills, social awareness, ethics and values, team work, leadership, creativity, etc. It will also help in identifying the traditional values and indigenous cultures along with diverse potentialities both in indigenous and developed scenario. There will be sessions by alumni, business leaders, outstanding achievers in related fields, people with inspiring life experiences as well as the university academic and research managers.

The first year of the course program comprises skill development courses along with other fundamental courses of agricultural science. After satisfactory completion of 42 credits of courses in two semesters of 1st year and subsequent satisfactory completion of 10 credits (10 weeks) of industry/ institute training/ internship, the student will become eligible for the award of UG-Certificate in Agriculture on exit. The students continuing the study further, would not have to attend the internship after 1st year.

The 2nd year has been designed with the skill development courses, basic courses as well as fundamental courses in agriculture with adequate theory and practical components, enabling the student to get acquainted with the basic principles and applications of agricultural sciences. After satisfactory

completion of the courses (84 credits) during first two years and subsequent satisfactory completion of 10 credits (10 weeks) of internship, the student will become eligible for the award of UG-Diploma in Agriculture on exit. The students continuing the study further, would not have to attend the internship after 2nd year.

During the 5th semester, the students will have a study tour of 10-12 days duration, which will be counted as 2 credits (Non-gradual).

The 3rd and 4th year courses have been designed to impart specialized knowledge to the students in the major disciplines. During the 7th semester, the students will adequately select 20 credits from a basket of elective courses, each course being of 4 credits giving an opportunity to them to gain advanced knowledge in frontier areas of agricultural science. The Universities will have flexibility to include more courses as Electives depending on specific needs and situational variations. The objective is to enable the student to acquire deeper understanding in any particular field.

In the 8th semester of the course the major focus has been on strengthening of the knowledge and skill for developing confidence of the students to take entrepreneurship as their future career. For this they will undergo an advanced skill enhancement through Student READY: RAWE/ Industrial Attachment /Experiential Learning / Hands-on Training/ Project Work / Internship. A student will select option/s on choice to complete the degree and pursue future career with 20 credits. Each student will be attached to a mentor either from the institution or from an organization/ industry. A university or a college will have the freedom to select the options as referred above.

The core and elective courses can also be modified maximum up to 30% with approval from competent authority of the University.

The students will take a minimum of 12 credits of online courses during four years as a partial requirement for the B.Sc. (Hons.) Agriculture program. The indicative list of courses has been provided; however, online courses can be from any field such as Agriculture and allied sciences, Basic Sciences, Humanities, Psychology, Anthropology, Economics, Business Management, Languages including foreign language, Communication skills/ Music, etc. and can be taken from NPTEL, Mook IT, edX, Coursera, SWAYAM or any other such reputed portal. The objective is to allow the students to groom their passion or strengthen their knowledge and competency in any field beyond prescribed courses. These online courses will be non-gradual and separate certificates would be issued by institute/organization offering the courses. However, the university/ institute will keep a record of such courses registered and completed by each student and indicate the title of the (successfully completed) courses in final transcript issued to the student. A student must submit the list of online courses along with the content he intends to undertake to the Principal of the college for a permission and records.

At each stage of exit (UG-certificate/ UG-Diploma and B.Sc. (Hons) Agriculture, the students are expected to acquire competency and confidence to get jobs, to face the real challenges in varied jobs and research, as well as to start their own enterprise. The social skills acquired by the students will also make the students more empathetic towards the society and social issues.

The credits (and contact hours) have been designed in such a way that along with class room teaching, the students will take up NSS/ NCC and Physical Education, Yoga, etc. in the first year as the case may be. Further a balance has been made by inclusion of common courses, core courses in basic and applied areas, skill development courses, elective courses in advanced areas, online courses of choice, options for entrepreneurship

and skill development to pursue future career. This will increase their acquaintance with the social/ technical problems, improve their analytical ability of the issues/ challenges and enhance their social responsibility.

EXAMINATION

There are two examinations in a semester, viz., Mid term examination and End term Examination. Mid term examination is conducted in the middle of the semester, whereas the End term and practical examinations are held at the end of the semester as per Academic Calendar. Besides, a student has to appear in quizzes/tests and carry out field/ laboratory/library throughout the semester. Any changes visit University/College website or Examination Section, BCKV.

EDUCATIONAL TOUR

There is provision of educational tour for the students. The tour is mandatory to the UG students and it carries 2-credit of weightage.

NSS

Students of the College of Agriculture shall have to participate in N.S.S. programmes. These programmes are open for the students of 1st and 2nd year UG programme on non gradational basis.

COLLEGE REGULATIONS

CODE OF CONDUCT FOR STUDENTS

1. Ramakrishna Mission Vidyapith Agriculture College always expects its students to conduct themselves with dignity, decency and decorum; they are expected to live up to a very high moral and social behavior even outside the college campus in consonance with the ideal of Ramakrishna Mission.

2. All the students are responsible for their conduct in the College premises. Students of this college shall abide by the prescribed rules or as may be made by the Principal or by the persons authorized by him from time to time. Disobedience, misconduct, misbehavior, sexual harassment or failure to comply with any of the rules will entail punishment including expulsion from the college.
3. The College Uniform is White Salwar, White Kameez and White Dupatta for girls and White Full Pant and White Full Sleeve Shirt for boys. Every student must wear the College Uniform & Identity Card during college hours. Failure to do so will entail a fine of Rs.100/- per violation. The Identity Card shall be returned to the College Office without fail for cancellation when the students leave the college.
4. No student should invite any outsider to attend classes, functions or for any other purpose without the prior permission of the Principal.
5. Students applying for certificates, testimonials, letters of reference or any other document requiring the Principal's signature should apply for the same in writing and claim them from the office after three days. No papers should be brought by the students directly to the Principal or Vice-Principal for signature.
6. Students should take particular care to be punctual at all lectures & practical classes. Absence from a single lecture must be justified in writing and if the prolonged illness is the cause, a medical certificate must be submitted on the day of resuming class. Record for absence due to participation in college activities to be submitted on the following day of the activity.
7. Students are required to have a minimum attendance of 85% per course to be eligible to appear for the Semester End Examination.

8. Any student having grievance about his/her attendance should inform the Principal in writing within three days from the date of declaration of attendance on the College Notice Board.
9. Students should read the notices displayed on the College notice board regularly. However, some urgent notices may be read out in the class-rooms.
10. Ragging is a cognizable offence and is banned in the institution. Anyone found indulging in 'ragging' is likely to be subject to appropriate, punitive measure which may include expulsion from the college by the Principal.
11. Students will form no association and will arrange no meetings in the College premises, without prior permission of the Principal.
12. Students should not loiter in the college corridor or cause disturbance on the College premises while the classes are in progress or at any other time.
13. Smoking and consumption of intoxicating materials in any form in the college premises is strictly prohibited.
14. Students are expected to take proper care of the college property and to help in keeping the premises neat and tidy; the damage done to the college property is a breach of discipline and will be dealt with severely.
15. Students will refrain from selling tickets or coupons of outside organizations in the college without the prior permission of the Principal.
16. Students must not give the college address for their personal mail.
17. Students are not allowed to use cell phones in the classrooms. Violation of this rule would result in confiscation.
